Court Coffers Are Dry. Now What?

Funding's running out for federal courts in New York and around the country, leaving a host of questions about how they'll function as the government shutdown enters a critical period.

Furlough notices for federal courts will be handed out around the country on Monday, per a memo from Administrative Office of the US Courts Director Robert Conrad. Funds slated to keep the court up and running ran out Friday, and the judiciary "will have no funding to incur obligations or make payments for most activities" now that we're on to "phase 2" of the shutdown, the memo says. With those comforting words, the impacts on New York's federal courts are still coming into focus. An Oct. 3 memo from Eastern District of New York Chief Judge Margo K. Brodie that I obtained said court staff should plan to stop receiving "regular salary payments" after Oct. 17.

"The Court may situationally furlough employees," the memo says. Not getting paid until the shutdown's over, per the memo: **court reporters**, **interpreters**, **or jurors**.

The Southern District of New York hasn't updated its guidance since Sept. 30, when it said "questions regarding how the funding situation may affect scheduling or proceedings in individual cases should contact the assigned judge's chambers directly."

Spokespeople for the Southern and Eastern Districts, which encompass Manhattan, Brooklyn, and the surrounding areas, didn't respond to requests for comment.

New York State courts won't be impacted.

"We'll start to see on Monday how different federal courts react to this," New York County Lawyers Association President Richard Swanson told me. "It may be different from district to district."

But without clerks, marshals, and other key court staff, "the whole system can grind to a halt,"



Swanson said.

For now, there are cases on the calendar and attorneys prepared to show. Here's some we'll be watching this week:

- Ex-Queens Defender chief Lori Zeno is scheduled to appear in Brooklyn federal court on Monday as she faces charges of stealing from the indigent defense organization that she ran. Judge Rachel P. Kovner is set to address the government's request for Zeno to wear an ankle monitor as she awaits trial. Docket
- The Second Circuit on Monday will hear arguments in a challenge to **New York's pistol licensing scheme**, including a provision allowing judges to serve as licensing officers. Antero
 Oliveira of Westchester says he was unconstitutionally denied a pistol license by a judge over past arrests that ended in case dismissals. **Docket**
- NXIVM **leader Keith Raniere** is set to argue for a new trial at the Second Circuit on Tuesday. Raniere says expert findings show that evidence presented at the trial images showing child pornography was falsified. Raniere, who led an "executive coaching" organization and a related secret society premised on "master-slave" relationships, was sentenced to 120 years in prison for sex trafficking, forced labor, racketeering, and child pornography. **Docket**
- Archegos' polo-playing head trader William Tomita faces sentencing Tuesday in Manhattan federal court. Tomita pleaded guilty and cooperated with prosecutors against founder William
 Hwang, who was sentenced to 18 years in 2024. Hwang was convicted of orchestrating a scheme to defraud banks into providing Archegos with billions of dollars in trading capacity that it used to inflate the value of its holdings until it imploded. Docket

Q&A: Anna Estevao, Diddy Defense Lawyer

Anna Estevao joined Manhattan-based boutique Harris Trzaskoma as a partner earlier this year. Among her first tasks: cross-examining Cassie Ventura at the sex trafficking and racketeering trial against Sean "Diddy" Combs, as part of Combs' legal defense team.

Harris Trzaskoma was formed this year by Justine Harris and Theresa Trzaskoma, who left Sher Tremonte to launch the firm. Before private practice, NYU Law grad Estevao cut her teeth as a federal public defender.

She told me about upsetting expectations at the Combs trial and her concerns for defendants'

discovery rights.

MV: Which of your past cases keeps you up at night?

AE: All of them. My clients come from different walks of life but each faces very serious challenges with enormous, potentially life-altering consequences. Being in their corner and doing everything I can to achieve the best possible outcome for them leads to a lot of sleepless nights.

What is the biggest challenge facing attorneys in 2025?

AE: Advocating for the underdog, particularly in the federal criminal system, has never been easy, but we're now living at a time when the very rule of law is in jeopardy, when prosecutors are experiencing enormous political pressure, and when basic legal protections are under threat. It will be important to find creative ways to navigate this new legal landscape.

When was the last time you were in a courtroom?

AE: Yesterday, I had a bail review hearing for a CJA client who happens to be facing the exact same charges that were brought against Sean Combs. I believe that everyone deserves a high-quality defense, and show up for each of my clients, whether retained or appointed, in the same way. Celebrity cases sometimes distract from the fact that everyday defendants also suffer similar injustices — overcharging, pressuring witnesses — and we can't lose sight that these are largely due to systemic problems.

What is one statute you'd add or repeal?

AE: For a start, I would ensure that criminal defendants have more robust procedural protections, including the right to depositions and greater subpoena power. It's a travesty that civil litigants are entitled to more discovery than criminal defendants whose liberty is at stake.

What book is on your bedside table?

AE: Call me a millennial, but I mostly read on my phone. Right now it's Haley Cohen Gilliland's "A Flower Traveled in My Blood," about Argentina's Dirty War. It's personal for me because my father was a student journalist in Argentina when he was kidnapped and held in a secret detention center for years before coming to the US as a refugee.

Is it better to be a bulldog in the courtroom or underestimated?

AE: As a thirty-something-year-old woman in this profession, I've only ever been underestimated. But more to the point, being a bulldog is not the only effective way to advocate for your client, so you really need to hone a variety of skills and modes.

Nobody expected me to cross-examine Cassie Ventura in Sean Combs' criminal trial, and we were able to upset everyone's expectations with a really nuanced approach. We didn't just follow the playbook of bashing the government's star witness; we knew something different was required in order to keep the jury with us and develop our defense themes.

It's the court lunch break and you're famished. Where are you going?

AE: The specials at the cafeteria at 500 Pearl are surprisingly good.

BNP to Pay \$20M to Sudan Refugees

BNP Paribas was found liable for aiding the Sudanese government's human rights abuses, with a jury awarding three refugees some \$20 million total.

The three bellwether plaintiffs are part of a class of 23,000. They were each awarded around \$7 million on Friday after a five-week trial.



"The jury recognized that financial institutions cannot turn a blind eye to the consequences of their actions," Bobby DiCello, an attorney for the plaintiffs, said.

The trial stemmed from a suit filed nearly a decade ago alleging the French bank knowingly helped a Sudanese dictator sell oil so the regime could use the proceeds for a violent ethnic cleansing campaign.

A bank spokesman said BNP has "strong grounds to appeal" and that "the verdict is specific to these three plaintiffs, and we strongly believe it should not have broader application beyond this decision."

But **Bloomberg litigation analyst Elliott Stein** said that **the verdict "could be costly"** and that he wouldn't "rule out a settlement in the low billions" as other class members press their claims.
